Gentlemen:

Due to a series of errors on the part of both the operator and the Commission the subject well has received no allowable since August 1, 1963. Referring to August Supplement No. A 12 and Mr. Armstrong's letter of August 9, 1963, you will recall that the well's allowable was originally canceled because of the operator's failure to file Commission Forms C-115 and C-116. These forms were then received by August 16, 1963, and the allowable should have been reassigned at that time. However, it was not called to my attention that these forms had been received until October 7, 1963.

We have, therefore, now prepared and are herewith sending, a supplement for the month of September, 1963, which not only covers that amount of oil which should have been assigned this well during that month, but which includes sufficient excess allowable to make up for that amount which should have been assigned the well for August, 1963. Further, since Form C-115 for the month of August, 1963, has not yet been received by the appropriate offices of the Commission, no allowable may be assigned the well for October, 1963. Commission Form C-115 must be in the mail by the twenty fourth day of the month succeeding the month for which the report is being filed.
