This well is cased with 7" to 255' with 250 sx, and 4 1/2" to 1798 with 250 sx and as the casing is circulated it will not be removed. According to the instructions from the U.S.G.S. office in Artesia, New Mexico we will place 15 sacks of cement from 1320 to 1480 covering the open perforations and 10 sacks of cement for a surface plug with a marker at the top. The rest of the hole will be mudded and the location cleaned and pit filled by a bulldozer.
