Plugging procedure to be as follows:

1. Squeeze off perforations @ 11,816' - 11,822'
2. Cut off casing. Fill hole w/mud and spot 100' cement plug from 9900' - 10,000'.
3. Spot 35 sack cement plug from 8250' - 8350'.
4. Spot 35 sack cement plug from 6900' - 7000'.
5. Spot 35 sack cement plug from 5300' - 5400'.
6. Spot 35 sack cement plug from 4150' - 4250'.
7. Cut off 8-5/8" intermediate casing and pull out of hole.
8. Set bridge and spot 30 sx cement plug from 2900' - 3000'.
9. Spot 30 sack cement plug from 2250' - 2350'.
10. Spot 30 sack cement plug 650' to 750'.
11. To sack plug at surface.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
