Plans have been made to clean out to 11,270' with sand pump. Perforate 5-1/2" casing at 11,238-40', 11,246-48' and 11,262-64' with 4 JHPF. Run packer on 2-3/8" tubing and set at 11,210'. Treat new perforations with 3000 gallons of 15% HCl acid. Raise packer and set at 11,100'. Swab and clean up and return well to production.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
