The well is uneconomical to operate and has no remaining primary reserves. The proposed procedure for plugging is as follows:

1. Cut and pull 10000' - 4 1/2" OD casing and 2200' - 7 5/8" OD casing
2. Spot 25 sacks cement over perp. 11042 - 11182'
3. Spot 25 sacks cement over cut-off casing point at 10000', over open hole at 7200 - 7360', over cut-off casing point at 2200' and at 725' - 675' and 10 sacks cement surface plug
4. Erect dry hole marker and restore location to original condition.
