# **SUPERIOR OIL**

## NATURAL GAS PIPELINE

The Superior Oil Company proposes to lay a 2945.6' Gas Pipeline from its existing well Sullivan Federal #1, located 660' FSL and 660' FWL of Section 5, T19S -R24E, Eddy County, New Mexico. This line will terminate via a tap-in into an existing NGPL line. A 3000 ft. X 30 ft. area has been staked and flagged down the center line.

The proposed pipeline as staked begins at a point that bears N46° 33'E, 806.3 feet from the South (SW) corner of Sec. 5, T19S, R24E; thence S10° 51'E, 46.0 feet; thence N89° 57'E, 2899.6 feet to an existing Pipeline. See Exhibit A.

The proposed line will consist of approximately 3000' of Schedule 40, 3", Double Random, yard coated pipe. The line will be buried 2 ft. in rock and 3 ft. in dirt.

Revegetation and rehabilitation of surface will be completed as per BLM recommendations.

The Sullivan Federal Lease contains, 1,287.72 gross acres, more or less, covering all of Sections 5 and 6, T19S - R24E, Eddy County, New Mexico. See Exhibit B. The proposed pipeline crosses no lease boundaries.

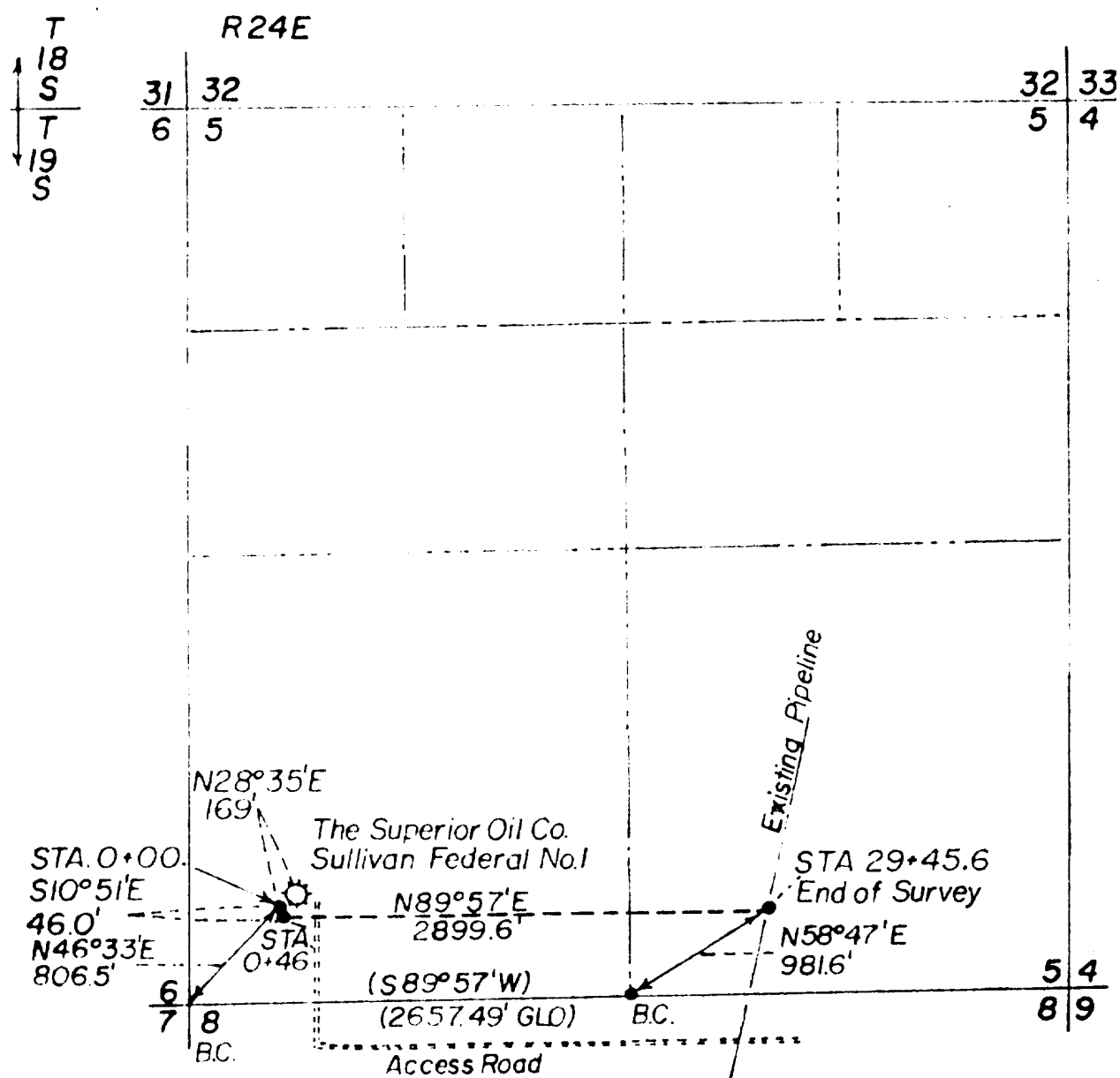
Archaeological Survey has been conducted and a copy is attached.

### DESCRIPTION:

Beginning at Engineer's Station 0+00, a point that bears N46°33'E, 806.5 feet from the Southwest (SW) Corner of Section 5, Township 19 South, Range 24 East, N.M.P.M., Eddy County, New Mexico; Thence, S10°51'E, 46.0 feet to Engineer's Station 0+46; Thence, N89°57'E, 2899.6 feet to Engineer's Station 29+45.6 and End of Survey. Said Engineer's Station 29+45.6 bears N58°47'E, 981.6 feet from the Southeast (SE) Corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 5.
