- 4-18-77 @ 2 P.M. Rig up and spudded 11" hole. Lost circulation at 25'. Dry drilled to 94'. Reamed hole to 17½". Ran 77' of 14" conductor pipe, cement w/ 7 yds. of ready mix. Lost circulation again @ 144'.
- 4-20-77 Cemented open hole w/ 100 Sks. class H w/ 3 % CaCl₂. Waited 2 hrs. and cemented stage 2 w/100 Sks. class H w/ 2 % CaCl₂.
- Dry drilled to 342'.
- Ran 324' of 8 5/8"; 24# J-55 casing, cemented with 100 Sks. class H w/ 2 % CaCl₂. W.O.C. 18 hrs. Pressure test casing and cement job to 500 P.S.I. for 30". Held OK. Fill back side with ready mix. 4-22-1977
