On 8-19-78, Landis Drilling Company (Rig #3) spudded a 17 1/2" hole at 11:00 A.M. Drilled to a total depth of 432' and ran 13 3/8" 48# H-40 ST&C casing and set at 432'. Cemented with 400 sacks Class C plus 2% CACL. Circulated 10 sacks. Plug down was 2:00 A.M. on 8-20-78. WOC 24 hours. Tested casing 1000# for 30 minutes. Reduced hole to 12 1/4" and resumed drilling.
