Spudded well @ 7:00 AM 13 November 1978. Drilled 17-1/2" hole to 333'. Ran and cemented 8 jts 13-3/8" 48# casing @ 333' w/325 sx Class "C" cement containing 2% CaCl₂. Plug down @ 12:00 Midnite 13 November 1978. Did not circulate. Filled annular space to surface w/6 yds. ready-mix. WOC 18 hrs. Tested casing w/500 psi - 30 mins - OK. Drilled out & drilling ahead w/12-1/4" bit.
