Drilled to depth of 372'. Rigged up and ran 13 3/8" - J55S - 48# casing to depth of 346'. Cemented casing with 350 sacks of Halliburton Class C. Cement circulated. After 12 1/2 hrs., pressured up on surface pipe to 1500 psi for 30 minutes. Tested O.K.. Job completed 7-22-79.
