This well was spudded 8/4/79. Set 20" conductor pipe at 30' and cmt'd with Redimix. Ran 5½ joints (230.59') of 13-3/8" OD 8R, H40, 48#, ST&C csg & set at 248.36' with 250 sx Class C w/2% CaCl. Cmt did not circulate. WOC 6 hrs. Ran temperature survey. Top of cmt 130'. Cmt'd 13-3/8" x 20" annulus w/3 yards Redimix to surface. Tested csg 500# - ok.

U.S.G.S. notified but did not witness job.
