O.T.D. 7968' Lime & Shale, OPBTD 7924'. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit, kill well w/produced water, ND WH, NU BOP's, release packer and POOH w/tubing and packer.
2. RIH w/OE'd tubing to 7500' and circulate the hole w/mud laden fluid. POOH w/tubing.
3. RIH w/4-1/2" CIBP on WL and set the CIBP @ 7575' and test to 1000#. Dump 3 sacks of cement on top of the CIBP. Run free point survey on 4-1/2" casing and cut off casing at free point. POOH w/4-1/2" casing.
4. RIH w/OE'd tubing to 50' below the casing stub and spot a 20 sacks Class C cement plug 50' below and 65' above the casing stub. POOH to 300' above the casing stub and WOC for 4 hrs. RIH w/tubing and tag the cement plug. POOH w/tubing to 4435'.
5. Spot a 26 sack Class C plug @ 4435 - 4335', across the top of the Wolfcamp. POOH w/tubing to 1600'.
6. Spot a 26 sack Class C plug @ 1600 - 1500', 1/2 in and 1/2 out of the 8-5/8" casing shoe @ 1551'. POOH w/tubing to 1300' and WOC for 4 hrs. RIH w/tubing and tag the cement plug. POOH w/tubing to 300'.
7. Spot a 28 sack Class C cement plug @ 300 - 197', 1/2 in and 1/2 out of the 13-3/8" casing shoe @ 248'. POOH w/tubing to 50'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
