T.D. 7145' Lime, PBDT 4275'. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit, kill well w/2% KCL water, ND WH and NU BOP.
2. Release packer set @ 4016' and POOH w/tubing and packer.
3. RIH w/5-1/2" CIBP and set @ approx. 4050' and dump 5 sacks of cement of top of CIBP.
4. RIH w/2-3/8" tubing to +4000' and circulate the hole w/mud laden fluid. POOH to + 3275' and spot a 10 sack cement (100') plug across the top of the Abo @ 3275 - 3175'. POOH w/tubing.
5. Run free point on 5-1/2" casing and cut off casing @ + 3000' or wherever free. POOH and LD 5-1/2" casing.
6. RIH w/tubing and load hole w/mud laden fluid. Spot a 18 sack cement (100') plug @ 3050 - 2950', half in and half out of the 5-1/2" casing stub @ 3000'. WOC and RIH to 2950' and tag cement plug. POOH to + 1885'.
7. Spot a 27 sack cement (100') plug @ 1885 - 1785', half in and half out of the 8-5/8" casing shoe @ 1835'. POOH to + 200'.
8. Spot a 28 sack cement (100') plug @ 200 - 100', across the 13-3/8" casing shoe @ 150'. POOH w/tubing and spot a 14 sack cement (50') surface plug @ 50 - 0' and install a 4" dry hole marker to designate a plugged and abandoned location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
