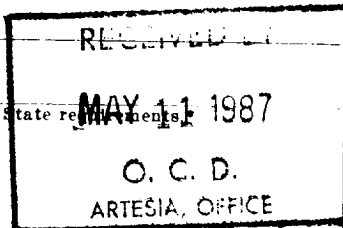

T.D. 7145' Lime, PBTD 4275'. This well was plugged and abandoned in the following manner:

1. MIRU a pulling unit, killed well w/25 barrels of 2% KCL water, ND WH, NU BOP, released packer and pulled tubing and packer.
2. Set a CIBP @ 4050' and dumped 5 sacks of cement on top of CIBP @ 4050 - 4015'. RIH w/OE tubing to 3993' and circulated hole w/mud laden fluid. POOH to 3282'.
3. Spotted a 10 sack (100') cement plug @ 3282 - 3182', across the top of the Abo. POOH w/tubing.
4. Cut 5-1/2" casing @ 2470' and POOH w/casing. RIH w/2-7/8" OD tubing and spotted an 18 sack (100') cement plug @ 2528 - 2428', 1/2 in and 1/2 out of the 5-1/2" casing stub @ 2470'. POOH w/tubing.
5. RIH w/OE tubing and tagged cement plug @ 2350'. POOH w/tubing to 1880'. Spotted a 27 sack (100') cement plug @ 1880 - 1780', 1/2 in and 1/2 out of the 8-5/8" casing shoe @ 1835'. POOH w/tubing. RIH w/tubing and tagged cement plug @ 1740'. POOH to 209'.
6. Set a 60 sack (209') cement surface plug @ 209 - surface. POOH w/tubing. Cut off WH and set a dry hole marker to designate a plugged and abandoned location.

Mr. Danny Cortez with the BLM located at Carlsbad, New Mexico witnessed the plugging of this well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
