7710'; WLPBTD 7#74' Frac'd perforations 7367-71' w/15000 gallons 5% MS, 7000 gallons 02, 1000 gallons 7-1/2% MS acid and 30000# sand (25000# 20-40 sand and 5000# 100 mesh sand). Recovered load. Well stabilized at 168# on 1/2" positive choke = 1130 mcfpd.
