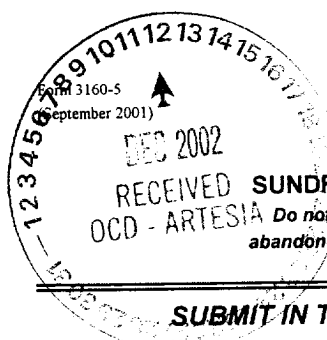

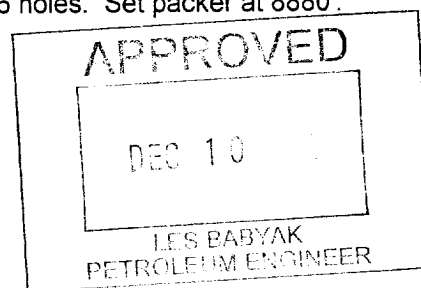

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Yates Petroleum Corporation proposes to set a CIBP at 9742'. Perforate Upper Morrow 9642'-9650' (36 holes), 9672'-9680' (36 holes) for a total of 72 holes. Stimulate as needed. Flow test and evaluate the Morrow sand. Consider turning well over to production. If not, then set RBP at 9610'. Perforate Strawn 9130'-9142' (13 holes), 9148'-9158' (11 holes), 9164'-9172' (9 holes), 9178'-9190' (13 holes) for a total of 46 holes. Set packer at 8880'. Stimulate as needed.
