Spud well @ 1 PM 12 Feb 82. Drill 9-7/8" hole to 350'. Loss circulation encountered at 55'. Dry drilled to 350'. Ran 9 jts 7-5/8" 26.0# J-55 casing and cemented @ 350' with 150 sx Class "C" with 2% CaCl<sub>2</sub>. Plug down @ 9:30 PM 13 Feb 82. Did not circulate cement. WOC 6 hours & ran temp survey. Found TOC @ 200'. Ran 1" tubing & cemented in three stages to surface with 125 sx Class "C" cement. After 22 hrs WOC, tested casing to 500 psi 30 min - OK. Drilled out w/6-3/4" bit.
