- 1) Rig up pulling unit. Kill well. Pull rods and pump. Install BOP. POH with tubing.
- 2) Go in hole with 7" retrievable bridge plug and set at 7810'. Dump 10 ft. sand on top of bridge plug.
- 3) Spot 150 gallons acetic acid from 7800' to 7707'.
- 4) Perforate the following interval with 2 JSPF: 7781'-7790' (10 feet, 20 holes).
- 5) Acidize perforations 7781'-7790' with 3000 gallons 15% NE-FE acid and 28 ball sealers. Maximum rate and pressure: 2 BPM, 7000 PSI.
- 6) Flow/swab back load. Retrieve RBP. Run pumping equipment and test.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
