6-6-95 - TIH with 2-7/8" tubing to 6050'. Spotted 82 bbls plug mud from 6050-2050' in 5-1/2" casing. Mixed and pumped 30 sacks Class C 2% CaCl₂ from 6050-5900' in 5-1/2" casing and 5-1/2" X 7-7/8" annulus. POOH with tubing. WOC. Rigged up wireline. RIH and tagged top of cement at 5840'. Ran and cut 5-1/2" casing at 2700'. Rigged down wireline. Rigged up casing equipment. POOH and laid down 5-1/2" casing. Rigged down casing equipment. RIH with 2-7/8" tubing to 2750'. Mixed and pumped 40 sacks Class C cement from 2750-2650'. POOH with tubing. Shut in overnight.

6-7-95 - TIH with 2-7/8" tubing. Tagged top of cement at 2644'. Spotted 20 bbls plug mud from 2644' to surface. POOH with tubing to 1950'. Mixed and pumped 45 sacks Class C cement from 1950-1850' in 9-5/8" casing. POOH with tubing. WOC 3 hours. TIH with tubing and tagged top of cement at 1839'. POOH with tubing to 400'. Mixed and pumped 40 sacks Class C cement from 400-300' in 9-5/8" casing. POOH with tubing to 50'. Mixed and pumped 20 sacks Class C cement from 50' to surface. POOH and laid down tubing. Cleaned location and installed regulation abandonment marker. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 6-6-95.
