Well was spudded at 0800 hours 4/9/88. Drilled 17 1/2" hole to 738'. Due to 5 1/2° deviation, a 500 sack cement plug was set from 738' to 435'. A 7 7/8" pilot hole was drilled through cement and re-drilled with a 17 1/2" bit to 757'. Ran 18 joints, 13 3/8", 54.5# and 48#, K-55 and H-40, ST&C casing to 757'. Cemented with 385 sacks Class "C" + 6% gel + 2% CaCl₂, tailed in with 250 sacks Class "C" + 2% CaCl₂. Bumped plug @ 1000 hours 4/15/88. Circulated 158 sacks to pit. Welded on casinghead and nipped up BOP's. Tested BOP's to 2500 psi, tested choke manifold, rams and kelly cock to 2500 psi. Tested casing to 1200 psi.

Drilled ahead with 11" bit to 2706'. Ran 66 joints 8 5/8" 32# and 24#, K-55, ST&C casing to 2706'. Cemented with 1100 sacks Class "C" + 6% gel, 10% salt + 1/4#/sack Celloseal. Tailed in with 250 sacks Class "C" + 2% CaCl₂ + 1/4#/sack Celloseal. Bumped plug at 2145 hours 4/19/88. Circulated 378 sacks to pit. Nipped up BOP's. Tested BOP and Hydril to 2500 psi, tested casing to 1100 psi. Resumed drilling with 7 7/8" bit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
