8/5/92: Test anchors. MIRU. POOH w/rods, pump. Install BOP. POOH w/tbg. Set 5 1/2" RBP @ 120'. Test BOP. Change out BOP & retest to 3000 PSI. Test OK. RIH w/5 1/2" RTTS pkr, SN & 2 3/8" tbg. Set pkr @ 8025'. Load annulus & tbg w/2% KCl water. Test tbg to 4000 PSI. Test OK. Stimulated well w/190 gal 15% HCl NEFE Acid, followed w/37 bbl 2% KCl, 8000 gal resisol acid. Swabbed well back. POOH w/tbg & pkr. PU & RIH 2 7/8" Guiberson nickel plated pkr w/2 7/8" X 2 3/8" X/O, on-off tool, F nipple, 2 3/8" N-80 duo line plastic lined tbg. N/D BOP. N/U well head. Displace annulus w/145 bbls inhibited pkr fluid. RU & test annulus to 500 PSI for 30 min. Test OK. RDMO.
