1. MIRU pulling unit. NU BOP's. WIH & DO DV tool @ 7506'. Tested to 1000#, held OK. Tagged cmt @ 8940'.
2. RU power swivel. DO cmt to float collar @ 8960'. Circ'd & POOH.
3. RIH on scraper run. Tagged PBTD @ 8960'. Tested BOP's to 1000#, held OK. Changed hole fluid to 2% KCl water. POOH.
4. RU wireline truck. Ran GR-CBL-CCL from PBTD to 2703'. RD wireline truck.
5. RIH w/2 3/8" tbg to 8120'. RU acidizers. Spotted 200 gals 15% HCl. RD acidizers. POOH.
6. RU wireline truck. RIH w/4" csg.guns. Perf'd 2nd Bone Spring Carbonate from 8072'-8120' (total 96 holes) w/2 JSPF. RD wireline truck.
7. RIH w/2 3/8" tbg, rods & pump.
8. Placed well on test.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
