3. Released 5 1/2" Baker lokset pkr & POOH w/260 jts. 2 3/8" TBG, SN & packer.
4. RIH w/MA, SN, Baker TAC & 268 its. 2 3/3" N-80 TBG, Removed BOP's & set TAC in 13,000 # tension. Installed TBG hanger.
5. RIH w/1 1/2" insert pump, 26K shear tool, 3400' 7/8" steel rods & 4833' 1" fiber-glass rods. Seated pump.
6. Set National C320-256-120 pumping unit w/8 1/2" X 10" Ajax engine.
7. Hung well on. RD pulling unit.
8. Placed well on test pumping to battery.
9. On 5/30/89 well pumped 334 BOPD, 0 BWPD & 341 MCFGPD.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
