- 3. A drawing of an API Series 900 Blowout Preventer Specification is attached. Pipe rams and blinds will be checked to the working pressure of the stack of 70% of the minimum internal yield strength of the casing whichever is less. BOPD will be checked when casing string is set.
- 4. The proposed casing program is as follows:

0'-1200': 9-5/8", 32#, K-55 0'-8100': 7", 26#, K-55

5. The proposed mud program is as follows:

0'-1200': 8.33 Fresh gel & lime 1200'-7500': 8.8 - 9.2 Cut Brine 7500'-8100': 8.3 - 9.0 Salt Gel & Starch

- 6. Run open-hole logs from 5000'-8100'. The log suite will include the following: 1) GR-DLL-MSFL-CAL, 2) GR-CNL-LDT-CAL. A temperature survey will be run to determine the top of cement on each casing string where cement is not circulated.
- 7. Possible waterflow to 900'. Known lost circulation from 0'-1100'. H₂S possible from 2000' to TD. Deviations from 4°-6° likely from 3000'-6000'.
- 8. The anticipated starting date is May 1, 1988 with a duration of approximately 25 days.
