Cemented w/700 sx Pacesetter Lite w/10%/sx Hyseal, 1/2#/sx Celloseal and 3% CaCl2 (yield 1.80, wt 12.7). Followed w/200 sx Class C w/2% CaCl2 (yield 1.32, wt 14.8). PD 2:45 PM 11-10-89. Bumped plug to 800 psi, float held okay. Cement circulated 75 sacks. WOC. Drilled out 8:45 AM 11-11-89. WOC 18 hrs. NU and tested to 3000 psi for 30 minutes. Reduced hole to 9-1/2". Drilled plug and resumed drilling.

NOTE: Change of hole size from 8-3/4" to 9-1/2"
