Notified Gary Williams, NMOCD, Artesia, NM. Ran 29 joints 9-5/8" 36# J-55 casing set 1270'. Guide shoe set 1270', insert float set 1233'. Cemented w/700 sx Pacesetter Lite w/10#/sx Hiseal + 1/2#/sx Celloseal + 3% CaCl2 (yield 1.90, wt 12.6). Tailed in w/200 sx Class C w/2% CaCl2 (yield 1.32, wt 14.8). PD 7:00 PM 3-21-90. Bumped plug to 1000 psi, released pressure and float held okay. Circulated 100 sx to pit. WOC. Drilled out 2:45 PM 3-22-90. WOC 19 hrs and 45 minutes. NU and tested to 1000 psi for 30 minutes, OK. Reduced hole to 8-3/4". Resumed drilling.
