Propose to add perforations in the Canyon as follows:

1. TOOH with pump. Nipple up BOP and TOOH with tubing.
2. Perforate 7632-7650' (Canyon) with 10 holes (1 SPF) as follows: 7632, 34, 36, 38, 40, 42, 44, 46, 48 & 7650'.
3. Straddle perforations 7632-7650' and acidize with 5000 gallons 20% NEFE HCL acid and ball sealers.
4. Pull RBP and put well on pump.
