Marathon Oil Company initiated completion operations on the above referenced well on 4-10-90. Following is the procedure:

1. MIRU pulling unit.
2. Install BOP's.
3. Drill out to 8553' KB. Test casing to 1000 psig.
4. Load hole w/2% KCl.
5. Ran GR-CCL-CBL under 1000 psig f/8549'-3500'. Good bond over zone of interest.
6. RU full lubricator & tested to 1000 psig.
7. Perforated Second Bone Spring Carbonate f/8056'-8178' w/2 JSPF.
8. Set RBP @ 8250' & test tubing to 5000 psig.
9. Acid fractured Second Bone Spring Carbonate f/8056'-8178' w/8000 gals 20% HCl & 8000 gals 2% gelled KCl w/225 balls for diversion.
10. Swabbed well in.
11. On 4-27-90 well potentialized @ 238 BOPD, 43 BWPD & 244 MCFGPD on a 20/64" choke w/FTP of 300 psig.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
