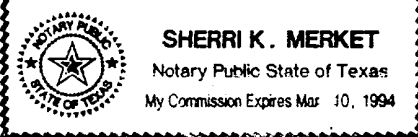

Marathon Oil Company initiated completion operations on the above referenced well on 9-26-90. Following is the procedure:

1. MIRU Pulling unit.
2. NU BOPS. RIH & drill out to 8481'. Tested to 1000#. Held O.K.
3. Ran GR-CBL-CCL f/8460'-2400'. Good bond across zone of interest.
4. RIH w/4" casing gun and perforate second Bone Spring Carbonate f/8017'-8080' KB (selectively) w/2 JSPF.
5. Acidized second Bone Spring Carbonate f/8017'-8080' KB with 5000 gals. 20% gelled HCl utilizing 120 ball sealers for diversion.
6. Swabbed well.
7. Acidized second Bone Spring Carbonate f/8017'-8080' with 25,000 gals. 20% gelled HCl and 27,000 gals. gelled 2% KCl.
8. Flowed well to recover acid.
9. Ran 2 3/8" production tubing.
10. ND BOPS.
11. Ran rods & pump.
12. Placed well on test.
13. On 10-5-90 well potential tested pumping 53 BOPD, 0 BWPD & 305 MCEGPD
