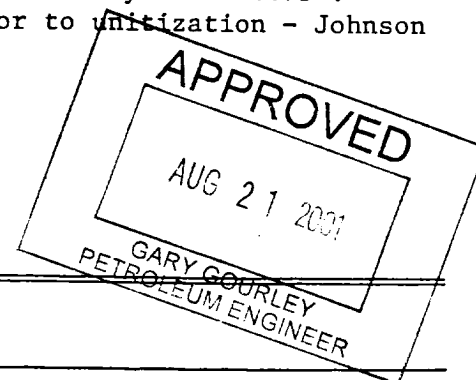

The Tamano (BSSC) Unit #410 is currently a shut-in injection well completed in the Second Bone Springs Carbonate which is the unitized interval. We have removed the well from the unit and plan to do the following:

1. Plug back the Second Bone Spring Caronate from 7998'-8080'.
2. Recomplete to the First Bone Spring Carbonate from approximately 5915'-6075'.
3. Change the well name back to the original well name prior to unitization - Johnson "B" Federal A/C 1 #10. (Lease Designation LC-029388-D)

We estimate rigging up on 8/1/01 and requiring 10 days.
