We propose to drill and test the Cisco and intermediate formations. Approximately 1200' of surface casing will be set and cement circulated to shut off gravel and casings. If commercial, production casing will be run and cemented, will perforate and stimulate as needed for production.

Mud Program: FW Fel/LCM to 1200'; FW to 4500'; Cut brine to 7500'; drispak/starch to TD.

BOP Program: BOP's and hydril will be installed on 9-5/8" casing and tested daily.
