1. POOH with pumping equipment.
2. Set CIBP at 7600' and cap with 35' of cement. NOTE: Perforations 7642-7734' (Canyon) will be below this CIBP.
3. GIH with tubing. Load hole with 2% KCL water. Test casing to 500 psi and record on chart.
4. POOH with tubing.
5. Install valve on casing.
