Tail in w/200 sx Class "C" + 2% CaCl2 (yield 1.32, wt 14.8). PD 10:00 AM 4-16-92. Bumped plug to 1000 psi, float held OK. Circulated 180 sacks. WOC. Drilled out 4:00 AM 4-17-92. WOC 18 hrs. Reduced hole to 8-3/4" and resumed drilling.
