7/9/01-Move in and rig up pulling unit. Rack and tally 2-3/8" and 2-7/8" L-80 tubing. TIH with 6-1/4" bit, collars and 2-7/8" tubing. TIH and tagged filled at 7400'. Cleaned out to 7441'. Recovered cement and mud. Continued to drill cement to 7681' top of liner. Dressed inside with 4-1/2 liner 6" TOH. TIH with 3-7/8" bit. 2-3/8" tubing and 2-7/8" tubing. Cleaned out 4-1/2 liner to 9323. 7-12-01 Moved in and rigged up Hughes acid trucks. Pickled tubing with 1000 gals 15% DI-HCL. Reversed out and rolled hole with 7% super fluid. Shut in. 7/13/01 moved in and rigged up JSI wireline. Ran GR/CCL/CBL from PBDT 9320' to 7600'. Perforated 9084-9088' (20) and 9098-9124' (108) 4 SPF. TIH with 4-1/2" Arrowset packer w/1.8 F 2-3/8" tubing and 2-7/8" tubing to 8784'. Set packer. 7/26/01-Loaded tubing and released packer. TOH with 2-7/8" and 2-3/8" tubing. Moved in and rigged up 3-1/2" L-80 tubing tally.
