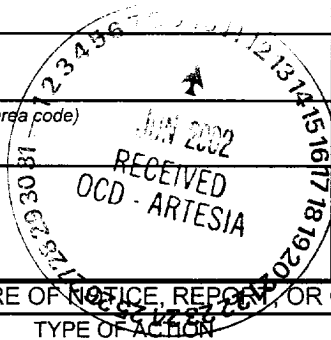

Propose to Temporarily Abandon this well for future use in secondary recovery efforts as follows:

Notify OCD with 24 hour notice before commencing operations

POOH with tbg and any downhole equipment.

Set CIBP at 7630'. Cap with 35' of cement.

Load hole with 2% KCL water with 1 gpt corrosion inhibitor.

Pressure test casing to 500 psi and record chart for 30 minutes. Submit chart to BLM.

If casing fails test, decide whether to look for holes or Plug and Abandon.
