Spudded 26" hole 7:15 PM 8-11-92. Set 40' of 20" conductor. Notified BLM, Carlsbad, NM of spud. Resumed drilling 14-3/4" hole 6:00 AM 8-13-92. Ran 24 joints 9-5/8" 36# J-55 casing set 1071'. Guide shoe set 1071'. Insert float set 1026'. Cemented w/200 sx "H" + 12% Thixad + 10#/sx Gilsonite + 2% CaCl2 (yield 1.55, wt 14.6). + 800 sx PSL "C" + 10#/sx Gilsonite + 3% CaCl2 (yield 1.94, wt 12.4). Tailed in w/200 sx "C" + 2% CaCl2 (yield 1.32, wt 14.8). PD 3:45 AM 8-15-92. Bumped plug to 1000 psi, float held OK. Circulated 210 sacks. WOC. Drilled out 11:45 PM 8-15-92. WOC 20 hours. NU and tested. Reduced hole to 8-3/4" and resumed drilling.
