12-9/10-92 T.D. hole at 3480' in the base of Capitan Reef, logged, Ran 84 jts 8 5/8" 32.0# K-55 STC casing, set at 3480'. RU BJ Services and cement w/ 125 sx Cl "C" Surefill (Thixotropic) w/ 8% A-10 + 1% CaCl2 + 1 pps cello-flake + 5 pps Gilsonite and tail in w/ 500 sx Cl "C" + 2% CaCl2, during the displacement, pumping @ 6-8 BPM with 15 BBLS left to displace, circulation was lost. Bumped plug at 2:45 A.M. CST 12-10-92. Temperature survey indicates TOC @ 2820' - minimum fill per APD was 200' inside 13 3/8" casing set at 2230'.

Our plans are to hang the 8 5/8" casing off in slips with the cement job as is. Drill out and T.D. 7 7/8" hole at 7000', log and run 5 1/2" casing and cement in two stages. We plan to place a stage collar at $\pm$ 3700' and circulate cement to surface inside the 8 5/8" casing. In the unlikely event that we plug the well, in addition to the required plugs we plan to spot a plug in the 8 5/8" casing shoe and fill the 8 5/8" casing with cement to at least $\pm$ 2000. The above was discussed with Adam Salameh on 12-10-92.
