Yates Petroleum Corporation respectfully requests permission to keep this well as a Pressure Monitor Well for a period of one (1) year in order to fully evaluate as follows:

1. Could be used as an injector or a producer if waterflood develops in the Dagger Draw area. Would like to leave as is and continue to monitor.
2. Well has been on vacuum during monitoring period. Pressure has increased to 12 psig. Yates Petroleum Corporation needs time to evaluate the pressure change and what caused the pressure change. Would like to continue to monitor the pressure to see if the pressure will increase.
3. Look at different waterflood patterns and scenarios.
4. Could be a possible deepening candidate for the Morrow. Will evaluate other Morrow wells in the area.
