5-22-02- Bled well down to tank. Pumped 45 bbls 2% down tubing; pumped 200 bbls down annulus - did not load. Released packer; NU BOP. TOH w/ packer; TIH w/ retrieving tool, latched on to RBP. Drive chain broke - repaired & released RBP. Pulled 5 stands, Shut in.

5-23-02- TOH w/ RBP; RU wireline. TIH w/ gauge ring & junk basket to 7500'. Set 7" CIBP @ 7455'. Cap w/ 35' cement. TIH w/ 7" packer to 5500' - set @ 6500'. Loaded tubing w/ 40 bbls; pressure to 500 psi, held leak off. Load annulus w/ 200 bbls; pressure to 500 psi - had slight communication w/ tubing. Possible tubing leak; closed in tubing. Pressure annulus to 500 psi, 30 psi lost in 10 minutes. Released packer; TIH to 7350' - Shut in.

5-24-02- Load hole, pressure to 500 psi. Displace hole w/ 2% KCL w/ 1 GPT corrosion inhibitor test & chart casing 500 psi for 30 minutes. Witnessed by Gene Hunt w/ BLM. TOH; lay down all tubing. ND BOP, cap well. Load w/ packer fluid. Rig down, move off. Well is T/A. Chart is attached.
