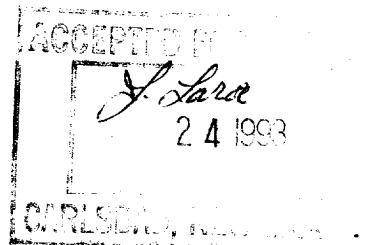
At 1645 hours on 6/14/93, we spudded this new well. On 6/15/93, we set 939' of 8 5/8", 24 ppf, J-55, ST & C surface casing in a 12 1/4" open hole. The casing was cemented to surface as follows:

280 sks Pacesetter Lite (35:65:6) + 2% CaCl₂ + 1/4 lb/sk Cello-seal
(Slurry Weight = 12.7 ppg, Slurry Yield = 1.86 cft/sk)

200 sks Class "C" + 2% CaCl₂

(Slurry Weight = 14.8 ppg, Slurry Yield = 1.34 cft/sk)

Cement was circulated to surface (170 sks).
