On 6-26-93, we set 4495' of 5 1/2", 15.5 ppf, J-55 production casing in a 7 7/8" open hole. The casing was cemented to surface with the following cement slurries:

475 sx Pacesetter LITE "C" (35:65) + 6% gel + 10% salt + 1/4 lb/sk Cello-seal (12.7 ppg)

510 sx Class "C" + 0.3% dispersant + 3% salt + 1/4 lb/sk Cello-seal (14.84 ppg)

We circulated 16 sx of cement to surface. The rig was released at 1645 hrs on 6/26/93. Currently, we are waiting on completion.
