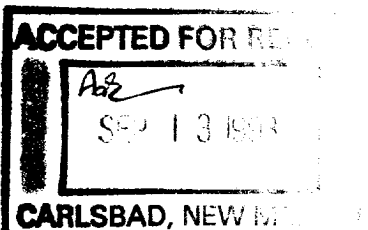

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)*

On 8/2/93, we perforated the Grayburg from 4033'-4050' and 4065'-4086' with a 4" casing gun (2 spf, 52 total holes). The perms were acidized with 2100 gals 15% HCl acid + 120 ball sealers. After flowback, the zone was determined to be wet. We set a CIBP at 4008' and dumped 35' of cement on top. Then, we perforated the Queen sand from 3844'-3856', 3829'-3838' and 3779'-3783' (2 spf, 53 total holes). On, 8/4/93, we acidized these perms with 1350 gals 15% NEFE HCl acid + 104 ball sealers. On 8/10/93, we fraced the perms with 29,000 gals gelled 2% KCl water + 50,000 lbs 20/40 sand and 15,000 lbs 16/30 sand. The well was flowed back immediately following the frac for forced closure. Currently, we are testing this well.
