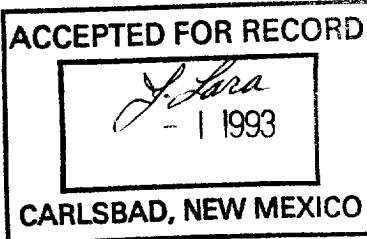

On 8-2-93, we perforated the Grayburg in this new well from 4033'-4050' and 4065'-4086', (2 spf, 52 total holes). The new perfs were acidized with 2000 gals 15% NEFE acid. We swabbed the well and recovered 100% water. On 8-3-93, we set a CIBP @ 4008'. Then, we dumped 35' of cement on top of the plug (estimated TOC = 3973').

The Queen sands will be perforated in this well and completed. A sundry notice will be submitted detailing the completion procedure.
