We spud this well at 1815 hrs on 7/11/93. On 7/12/93 we set 972' of 8 5/8", 24 ppf, J-55 ST & C casing in a 12 1/4" open hole (open hole depth = 976'). The casing was cemented to surface with the following cement slurries:

280 sx LITE (35:65) + 6% gel + 2% CaCl₂ + 1/4 lb/sk Cello-seal
(slurry weight = 12.7 ppg, slurry yield = 1.86 cft/sk)

200 sx Class "C" + 2% CaCl₂
(slurry weight = 14.8 ppg, slurry yield = 1.34 cft/sk)

We circulated 104 sx of cement to surface.
