On 7/20/93, we TD'd this new well at 4500'. On 7/21/93, we set 4500' of 5 1/2", 15.5# J-55 production casing in a 7 7/8" open hole. The casing was cemented to surface with the following cement slurries:

500 sx Pacesetter Lite (35:65) + 6% gel + 10% salt + 1/4 lb/sk cellophane flakes
470 sx Class "C" + 3% salt + 0.3% dispersant + 1/4 lb/sk cellophane flakes

We circulated 48 sx of cement to the pit.
