We spudded this new well on 5/17/93 at 1300 hours. On 5/19/93, we set 985' of 8 5/8", 24 ppf, J-55 ST&C surface casing in a 12 1/4" open hole. The casing was cemented with:

280 sks 35:65 (Poz:Class C cement) + 6% gel + 2% CaCl₂ + 1/4 lb/sk cellophane flakes mixed at 12.7 ppg (1.86 cft/sk yield)

200 sks Class C + 2% CaCl₂ mixed at 14.8 ppg (1.34 cft/sk yield)

Cement was circulated to surface (50 sks). Capstar Drilling Rig #6 is drilling the well.
