On 5/30/93, we set 4400' of 5 1/2", 15.5 ppf, J-55 production casing in a 7 7/8" open hole. The casing was cemented to surface with:

520 sx Pacesetter Lite (35:65:6) + 10% salt + 1/4 lb/sk Cello-seal
(slurry weight = 12.7 ppg slurry yield = 2.04 cft/sk)

500 sx Class "C" + 0.3% CF-2 + 1/4 lb/sk Cello-seal
(slurry weight = 14.8 ppg slurry yield = 1.32 cft/sk)

We circulated 50 sx to surface. The rig was released at 1600 hours on 5/30/93. Currently, we are waiting on completion.
