13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. On 7/6/93, we perforated the Queen in this new well from 3840'-3850' (21 holes), 3822'-3832' (21 holes), 3766'-3770' (9 holes), 3749'-3753' (9 holes), 3420'-3437' (35 holes), 3404'-3414' (21 holes) and 3398'-3400' (5 holes). The perfs were acidized with a total of 3000 gals 15% NEFE HCl acid and ball sealers the next day. We swabbed back the load and ran production equipment. On 7/22/93, we set a packer at 3647' and fraced the Lower Queen perfs from 3749'-3850' with 28,500 gals linear gelled 2% KCl water + 50,000 lbs 20/40 sand and 15,000 lbs 16/30 sand. The well was opened for forced closure flowback immediately following the frac. Currently, we are cleaning out the wellbore and testing.
