Newsco frac'd UQ2 perfs 3398-3437' w/10,000 gals X-link gelled 2% KCl water + 25,000# 20/40 Ottawa sd + 4000# 20/40 RC sd + 3318 gals Un-X-link gelled 2% KCl water flush. Washed 60' sand off RBP at 3600'. Latched RBP and reset at 3375'. Press tested RBP to 1000 psi

03-30-95 RU Wedge WL. Ran 4" csg gun. Perf'd UQ1 w/1 JSPF from 3312-3326' w/15 holes (.40" EHD). Ran full bore packer on 2 7/8" tbq. Spotted acid at 3326' across full bore packer to 200' and set in tension. Newsco acidized UQ1 perfs 3312-3326' w/1000 gals 15% NeFe acid + 30 BS + 823 gals flush. Flwd well back. POH w/tbq and packer.
