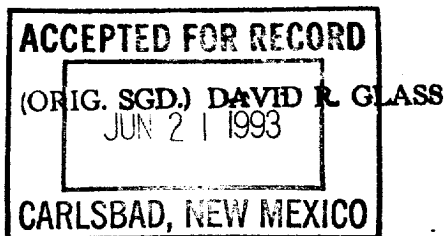

We spudded this new well on 5-31-93 at 2300 hrs. On 6-2-93, we ran 971' of 8 5/8" 24 ppf, J-55 casing in a 12 1/4" open hole. We cemented the casing to surface with:

280 sx Pacesetter Lite (35:65:6) + 2% CaCl₂ + 1/4 lb/sk Cello-seal
(slurry weight = 12.7 ppg slurry yield = 1.86 cft/sk)

200 sx Class "C" + 2% CaCl₂
(slurry weight = 14.8 ppg slurry yield = 1.34 cft/sk)

We circulated 75 sks to surface.
